Always examine your tax receipt to see that it covers all your property. Office hours are 8:00 A.M. to 4:00 P.M. Monday through Friday - Closed Saturday.

Failure to receive tax statements does not avoid any penalty, interest, or charge incurred for such delay. If you have not received a tax statement prior to the closing date,

please call the Treasurer's Office at 740-992-2004.
