**IT'S THE LAW (ORC 955.01)**

All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.

(The law applies regardless of whether the dog is kept inside or out.)

**Due to the COVID 19 pandemic, we ask if at all possible, that you use the attached dog license application to purchase your 2021 dog tags by mail.**

Instructions for purchasing Meigs County Dog Licenses:

**BY MAIL**

- 1-Complete this form.
- 2-Use this form to register 1-5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form.
- 3-Enclose a check or money order for the correct fees payable to: **Meigs County Auditor**. Please do not send cash.
- 4-Send the completed application and payment to the address above.

**Please included a self-addressed, pre-stamped envelope for the return of your tags and receipt.**

**IN PERSON**

If you are unable to purchase your license by mail, you may purchase them in person at the Meigs County Auditor's.

Dogs may be registered for a 1 year or 3 year term, or permanently.

Complete each line of the application for your dog(s). In particular, choose your "Term" (1 year, 3 year or Permanent--see term codes below) and fill in "Fee Paid" based on the fee structure to the right.
